

Vertikal Typeface
End-User License Agreement
(EULA)

1
This agreement (EULA) is between you, the purchaser and licensee (thereafter you) and Simon Wahlers. By purchasing, downloading and installing digital typeface software (typeface(s)/ fonts), you accept all terms defined in this agreement. If you don't accept those agreements, you are not permitted to install or use any typeface(s) provided by Simon Wahlers.

You are granted one license to use the typeface(s) on a certain number of workstations inside your company or organization. You do not receive any copyrights to the design or any other parts of the Typeface(s), but the rights to freely use the typeface(s) within the in accordance of this agreement. Using the typeface(s) in your company or organization, does not include the usage of clients or any other third parties. If the font software needed by any third parties, they have to acquire their own license.

3.1
By purchasing a typeface, the license does not give you ownership of the font software. After payment, you receive a non-exclusive, limited license to use the typeface(s) in accordance to the EULA. Therefore, all font software, trademarks, electronic data, designs and names always remain the exclusive property of Simon Wahlers.

3.2
All license-types include use for print, websites, mobile apps, electronic publications, broadcasting, videos and films for a variety of workstations in one business place. S The standard License (S) al-

lows the use of the Typeface(s) for 1-5 users and a number of 1-10,000 website views per month. M The medium License (M) allows the use of the Typeface(s) for 6-20 users and a number of 10,001-30,000 website views per month. L The large License (L) allows the use of the Typeface(s) for 21-50 users and a number of 30,001-100,000 website views per month. XL The extra large License (XL) allows the use of the Typeface(s) for 51-100 users and a number of 100,001- 200,000 website views per month. XXL For licenses bigger than S, M, L and XL please get in contact and receive a personal offer.

3.3
Trial-Fonts are exclusively for testing purposes. If you received a trial version after personal consultation and decide to use the typeface(s), please contact Simon Wahlers for the licensing. Trial-Fonts must not be used for any commercial projects in any way.

4
Archival copies of the fonts are permitted for your personal purposes. You are not allowed to redistribute the files to third parties in any way.

5
You are not allowed to modify the font under in any way under any circumstances. You may not commission a third party to modify the typeface(s). If you want a customized version of the typeface(s), please get in contact. I provide custom services from single glyphs up to whole families. After requesting this service, I will make an offer with the price and conditions.

6.1
It is prohibited to redistribute, lend, rent, sell, give away, reproduce, copy publicly or privately share

any files of the typeface(s). Webfont-files may be uploaded to private-hosted servers. Webfont-files may not be generated from any other font-files.

6.2
It is highly forbidden to use the typeface(s) in any racist, sexist, homoor transphobic, fascist or generally discriminating way. You may not use the typeface(s) to promote anything harming the environment in any way. If you purchase a license for a project in any of the fields stated above, you are not allowed to use the typeface(s) and will not get a refund for already purchased licenses.

All purchases are final, and you will not be refunded once you bought any license.

8
If you have problems with the font software, don't hesitate contact me. I will look at any problems and hopefully be able to come up with a solution for any difficulties.

Any violation of the terms and conditions stated in this agreement will result in the termination of your license, and you won't longer be allowed to use the typeface(s). After the termination of the agreement, you are obliged to destroy any copies of the font software.
